

Case old 1/1983

My friend Martha told me that her friend from Barcelona was suffering from Cancer and she was given a few weeks to live, I asked them to come to Las Palmas, and she and her husband both came running.

Talking to them, I found that she was under great emotional stress, her mother was staying in the house, and there was an eternal fighting and bickering between the grand mother (Nani) and the grand children, she said it was her daughters house, and told the children to get out, and the grand children said, it was their house and the grand mother should leave the house. These bickering were taking seriously by the patient from both sides, and were going through emotional suffering of the highest degree, which in my opinion was the cause of her problems.

I recommended to her to be brave and tell the mother and the children to get out of the house, it was difficult to convince her, but when she did what she was told, none of them left the house, and she was cured and is still alive.

#### Case 1/95 Mrs. S K

In January 95 my friend B.M's wife Mrs. K in Pune India had specifically mentioned that I look after her friend Mrs. S.K. who was suffering from Leukemia, and was getting worse every day, and the doctors had given up on her.

She was invited to come to the clinic at Sadhu Vaswani Kunj, Pune. Talking to her I found a gap of 17 years between both her children, (no longer children any more) which is not normal. Upon enquiring, she confessed that she had a married daughter, who insisted in going to her troublesome husband in New Delhi, much against the patients will.

Once in New Delhi, her daughter, as the patient, the mother had expected, had problems with her husband and had committed suicide, after killing her own small child, so that the husband may not torture the little child.

The patient's guilt suffering was killing her from inside, that she should not have allowed her daughter and grand child to go from Pune to New Delhi, and if she had been firm, she was convinced, both would be alive today, and that guilty thought day and night had turned into leukemia.

Once she confessed, I assured her that according to the law of Karma (Action and reaction of the past lives), her daughter's days were over, and there is nothing which could be done right or wrong, which would have prolonged her daughter's or grand daughter's life, and that even if she had managed to be alive, she would be suffering and making every one around her suffer more and more.

The patient started crying for a long time, and upon reinforcing and repetition the patient was convinced, that she was not to blame and what had happened was the will of God, and once that happened, she was on the road to recovery and has been improving since and is very much alive and active, and getting healthier.

#### Case 2/95. Mr. N.W

In this case the same friend Mr. B.M, at the end of December 94, had informed me that the patient N.W. had been operated of tumor of the prostate, but was not progressing. Upon asking if she had had any emotional problems in the last few years, he said may be I was right but I should talk to him directly.

Mr. N.W. kept an appointment with me various times but failed to turn up. I got the impression that he was running away from himself.

One day also in January 95, we happened to go to Lonavala from Pune, a drive of about 1 1/2 to 2 hours, and it just happened that we travelled together in his car, or my friend Mr. B.M. "arranged" that we go together.

Mr. N.W. was a self made man. He had left a bank job in India and gone to Vietnam many years ago, and started supplying to the Govt. of India, and many other Indian clients, and made quite a few million US\$.

Everything went on very well, until one day some client of his in India, on the surface being very big, to whom our patient Mr. N.W. had extended a very large credit, went out of business, where Mr. N.W. not only lost everything but was actually minus.

The banks were helping him out in every way, (Later I realized that the banks felt, Mr. N.W. was the only one who could reduce their losses and was actually doing so) but the sons felt, it was impossible to recover such large losses, no matter how much they worked, and they would be working as slaves without making any progress, and Mr. N.W. was fighting against odds, and in the process had not been happy with his sons and every one had suggested to him to abandon the project, and at least save his very high pension of nearly US\$ 3,000 a month, which he was paying to the bank too.

In the car both onwards and backwards, I convinced him that he was fighting a loosing financial battle, and if God wanted him to pay his debt, by this time he would have made a lot of money as he had done in the past, and he had to accept the will of God, and stop struggling in the loosing battle, where with all his efforts, he was in tension all the time and not able to pay even the interest to the banks, who were going along with him, as they had no other option, and since his wife had a house in Bombay, his pension which the banks were not nor could touch legally, should be saved and would help him and his wife to live in peace and prosperity without undue tension. He was made to realize that what he was told made economic sense. His sons had told him the same thing, but this advice coming from myself, the independent advisor, and putting it in crystal clear terms, and in the name of God, which he very much believed in, he stopped struggling with himself, and was on the road to recovery. His prostate operation, which was not healing in the past, suddenly took a turn for the better, and is of course getting better and better every day.

#### Las Palmas 1996

Additional case In 1996 we visited Byass, and our hosts asked us why people suffered from Heart & Cancer problems, I knew there was a problem, and told her that when you had trusted your own brother most, who had done you in, and you brood, without consciously realizing and you continue brooding over the subject, she was taken a back.

Later when we sat down, she confessed that she had treated her brother in law (Husbands brother) better than her own son, which is quite common in India, gut feeling told me the rest. I told her I knew the whole story.

I made her realize, that since her brother in law had robbed the firm and left, her sons had emancipated, were now in active business, and more prosperous, her husband was away from the pressure from his younger brother, and had better heart, she admitted that was so, and I convinced her that God had been good to her by her brother in law taking away some money, and after she went through the forgiving Page 187 (see website), her post operative pain in the arm which her surgeon had told her that she would have to live with it, disappeared the same afternoon and she is very much active alive, much to the surprise of the doctors.

The patients in all cases have been advised to:

a) Change their diet, avoid salt, sugar, Milk, Flour (and products thereof in both cases), meat, fried things, and to go on the raw, ripe and freshly cut fruits and vegetables diet, and sprouted grains (avoiding too many mixtures) to be eaten slowly, and chewed well.

We lost contact with him, as he left his rented apartment in Pune and went to a new city in India, and before my departure from India in early February 95, I could not contact him and/or his wife, but was assured that he was very much alive.
